QUOTATION NOTICE

The Brihanmumbai Municipal Corporation invites sealed quotations from eligible bidders who are not blacklisted by any Government, Semi-Government, Local Authority or Municipal Corporation for running the Municipal Pay & Park Scheme at Haribhau Rupwate Marg, Goregaon (West) (From Shrirang Sabde Road to Best Colony Road) in P/South Ward on license basis for a period of **six (06)** months from the date of issue of the Letter of Acceptance/Work Order.

The successful bidder shall operate and maintain the Pay & Park Scheme at his own cost by deploying the required manpower and providing all necessary operational arrangements. The licensee shall recover parking charges from vehicle owners/drivers strictly as per the rates approved by the Brihanmumbai Municipal Corporation. The Hand Held Device (HHD) along with the required software and hardware, connected to the centralized server, shall be provided by the authorized web-based parking agency/BMC.

The quotation shall be submitted in two sealed envelopes, namely Packet "A" (Technical Bid) and Packet "B" (Financial Bid), super scribed "Quotation for Running Municipal Pay & Park Scheme at Haribhau Rupwate Marg Goregaon (W) (from Shrirang Sabde road to Best Colony road) and addressed to the Assistant Commissioner, P/South Ward, on or before 10.08.2026 up to 3.00 p.m. Packet "A" shall contain all required documents along with the Earnest Money Deposit (EMD) in the form of a Demand Draft. Quotations not accompanied by the prescribed EMD shall be treated as Non-Responsive and shall be rejected.
