E-TENDER NOTICE

Subject: Supply, installation, testing and commissioning of smart electrical actuators for butterfly valves at Mahavir Nagar Tunnel station and Liberty Garden Tunnel station under A.E.W.W.(M)W.S. / North division.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on **Item Rate / Percentage Rate** Basis to appoint Contractor for the aforementioned work from **Manufacturers / authorized dealers / distributors of manufacturer / contractors** who are dealing with such type work of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with Brihanmumbai Municipal Corporation (BMC) in Mechanical & Electrical Engineering discipline in Class 'A' as per old registration or in class 'A' as per new registration or as superior classes and from the contractors/firms equivalent or superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, **the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.**

- i. The forms of Tender documents are available on the e-Tendering website <https://mahatenders.gov.in>. The aspiring Applicants will have to download Tender form, from the website mentioned above by online payment of Tender Fee of Rs. 18847/- (Rs.15972/- + 18% GST) (As per circular no. CA/FRG/15 dt. 20.03.2026). The bidder has to fill in online format and upload information regarding Tender Online. Also, he has to download the Tender application form from website, fill it and upload the scanned copy of duly filled form, along with required documents.
- ii. For purchasing the Tender documents, the bidders will have to get registered with e-tender portal (<https://mahatenders.gov.in>) for the e-tendering process and obtain login credentials to participate in the online Tender process. - 1) **Mode of payment of EMD:** The bidder shall pay entire amount of EMD i.e. Rs. 85,400.00 through payment gateways of GoM on URL <https://mahatenders.gov.in>. The bidder shall upload scanned copy of online paid EMD along with the bid submission in Packet 'A'. Any bid not accompanied by an acceptable bid security shall be rejected by the employer as non-responsive.
- 2) **If non-responsive:** "If the bidder is found non-responsive after scrutiny of Packet 'A' / 'B', in such circumstances, **the bidder will be made non-responsive and financial packet C of non-responsive bidder will not be opened. However, there will not be any forfeit of EMD.**
- 3) **Shortfalls:** Maximum 5 shortfalls of curable defects shall be allowed and in case, curable defects are not complied by the bidder within given time period, the bidder shall be treated as non-responsive and such cases will be informed to registration and monitoring cell. Such non submission of documents will be considered as intentional avoidance and if three or more cases in twelve months are reported, shall be viewed seriously and disciplinary action against the defaulters such as banning/ deregistration etc. shall be taken by registration cell with due approval of the concern AMC.
- 4) **Refund of EMD:**
 - a) Except successful bidder all the other unsuccessful bidder's 100% EMD paid online will be refunded automatically.
 - b) The bid security of successful bidder will be discharged when the bidder has signed the agreement and / or furnished the required security deposit as elaborated in Standard Bid Document.
- 5) **Forfeiture of entire EMD:** The Existing conditions laid down in Standard Bid Document regarding forfeiture of entire bid security (EMD) shall remain unchanged.

Note: These interim instructions will remain in force till the issuance of circular regarding amendment in SBD.

The Applicant has to prepare & submit Tender Documents Online on or before last date of submission as mentioned in tender notice. The Applicant should upload the documents in readable form, He should take trial of uploads by taking printout. The unreadable documents will be treated as null & void. The remaining documents will be evaluated. The decision of opening Authority regarding this will be binding to all applicants. This tender document is not transferable.

Packet A, B & C shall be opened on dates as mentioned in header data. All the responsive and eligible bidders if they so wish can be present at the time of opening of bids, in the office of Executive Engineer (Maintenance) Meter Workshop. The Packet C shall be opened if bids submission in Packet A & B satisfies/includes all the requirements and same are found acceptable to the Authority.

The Municipal Commissioner reserves the right to reject all or any of the e-tender(s) without assigning any reasons at any stage.
