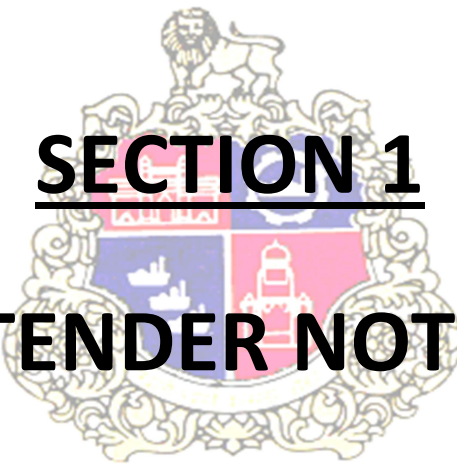

**Subject** : Providing Various Mechanical Services for Emergency / Repair Maintenance Activities in the Western Suburban Area under A.E.(Maint) W.W. W.S. South Section.

The Brihanmumbai Municipal Corporation (BMC) invites e-tender on ~~Item-Rate~~ / **Percentage Rate** basis to appoint Contractor for the aforementioned subject work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary / Partnership Firms / Private Limited Companies / Public Limited Companies / Companies registered under the Indian companies' act 2013, the contractors registered with the Brihanmumbai Municipal Corporation (BMC) in appropriate Class 'AA' as per old registration and Class 'A' as per new registration) and / or firms dealing in the line, contractors / firms equivalent and superior classes registered in Central or State Government / Semi Govt. Organization / Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with BMC will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited / recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

The applicant has to pay Tender Fee of **Rs. 4,712.00 (Rs. 3,993 + 18 % GST)**. Tender fees including applicable GST shall pay before due date of tender on Mahatenders portal online (As per Circular No. CA / FRG / 15 dtd 20.03.2026). W.r.t. circular mentioned updating of tender fee / EMD details in SAP using t-code ZFI\_MT\_CLERK & ZFI\_MT\_OFFICER etc. and also refer the bank details to be updated on Mahatender portal for acceptance of EMD / ASD. Tender Fee is non-refundable and nontransferable.
