The Brihanmumbai Municipal Corporation invites Quotation on item rate basis for the work of "Supply of leather links of air blowers at Filtration Plant Bhandup Complex.", as per technical specifications and requirements.

The quotationer shall be a BMC registered Vendor. If the quotationer is not having BMC vendor registration number then they shall obtain the same from Central Purchase Department (CPD), Office at Byculla, Bakariadda, Mumbai prior to purchase of quotation.

The quotationer shall get registered with e-tender portal (<https://mahatenders.gov.in>) and obtain login credentials to participate in the online e-quotation process. The quotationer shall have BMC vendor registration and shall be OEM or authorized dealer / authorized agent of M/s. TMVT Industries Pvt.Ltd.(OEM). In case of authorised dealer / agent.The quotationer shall submit the 'Authorization Certificate' from M/s. TMVT Industries Pvt.Ltd.in BMC prescribed format. The quotationer shall have supplied spares / material for any mechanical equipments during last Three years in B.M.C. or any govt. / semi govt. sector. The quotationer shall upload the scanned copy of the original proof of the completed work i.e. the Work Order and Completion Certificate both signed by the competent authority, to substantiate the similar type of completed work. If the quotationer fails to upload the same their bid will be outrightly rejected.

Similar Experience: Similar experience means quotationer shall have supplied spares / material for any mechanical equipments,during last Three years in BMC department/ Government/Semi Government/ Public Sector Organization. The scanned copy of the original Work Order with Number, Date, Contract Period & Cost Of The Work with Completion Certificate shall be annexed by the quotationer while submitting the offer.
