The Lagoons at Ghatkopar, Bhandup and Versova WWTF are provided with treatment ponds and floating Aerators arrangement. Malad WWTF is provided with screens and grit chamber facility. Considering similar nature of WWTFs at Ghatkopar, Bhandup and Versova, it has been decided to allot maximum two (02) contracts to one (01) successful bidder, if he is participating in all the three (03) bids invited for Ghatkopar, Bhandup and Versova WWTF and found lowest responsive in all the three (03) bids. Any two contracts which are the most beneficial to BMC will be awarded to that bidder. The award of contracts will be entirely BMC's discretion.
