The Brihanmumbai Municipal Corporation (B.M.C.) invites e-tender <u>PERCENTAGE</u> <u>RATE BASIS</u> to appoint Contractor for the aforementioned work from contractors of repute, multidisciplinary engineering organizations i.e. eminent firm, Proprietary/Partnership Firms/ Private Limited Companies/ Public Limited Companies/Companies registered under the Indian companies' act 2013, the contractors registered with the Brihanmumbai Municipal Corporation, (B.M.C.) in <u>Class '.....'</u> as per 2016 Registration in Mechanical and Electrical category except those who are blacklisted or against whom FIR has been filled and from the contractors/firms equivalent and superior classes registered in Central or State Government/Semi Govt. Organization/Central or State Public Sector Undertakings, will be allowed subject to condition that, the contractors who are not registered with B.M.C. will have to apply for registering their firm within three months' time period from the award of contract, otherwise their Bid Security i.e. E.M.D (Earnest Money Deposit) will be forfeited/recovered and an amount equal to Registration Fee of respective class will be recovered as penalty.

Bidding Process will comprise of THREE stages.

Bidder should note that the **Tender Scrutiny fee of Rs. 7620/- + 18 % GST** will be payable immediately after opening of Packet A and B in any of the Ward Citizens Facilitation Centers (CFCs) as per Circular No. CA/FRG/17 dt. 17.03.2025.
