The Brihanmumbai Municipal Corporation invites e-quotation on item rate basis for the "Repairs to 75 H.P./ 55 KW Electric motor of Air Scour Blower at Filtration Plant, Bhandup Complex."

### **QUALIFICATION / ELIGIBILITY CRITERIA :**

The quotationer shall be registered as Electrical Contractor towards Government of Maharashtra and shall produce the copy of valid license.

The quotationer shall have executed the similar work during last seven years in B.M.C. or any govt. / semi govt. sector. They shall have upload proof of the same i.e. completion certificate of competent authority.

**Similar Experience:** Similar experience means the work of repairs to at least 50 HP electric motor . The copy of the work order with number, date, contract period & cost of the work with completion certificate shall be annexed by the e-quotationer while submitting the offer.

**E-QUOTATION TENDER FEES:** The e-quotationer shall make online payment of e-quotation tender Fees of Rs. 363.00 + 18% GST (9% CGST + 9% SGST) on mahatender portal (mahatenders.gov.in).

### **Earnest Money Deposit (EMD) payment:**

- 1) The e-quotationer shall pay the earnest money deposit on line.
- 2) The registered Municipal Contractors having standing deposit with BMC shall also have to pay Earnest Money Deposit for this e-quotation.
